Meeting with Chance in January sounds great. I also just spoke with Leah Simon-Weisburg today, she's the Legal Director of the Alliance of Californians for Community Empowerment (ACCE), Chair of the Berkeley Rent Board, author of numerous rent control ordinances (including Richmond's), and a tenant lawyer with experience in nearly all of California's rent control districts. She provided us with our <u>model ordinance</u> and said she would be happy to attend a council meeting and present an expert perspective on the efficacy, history, and/or mechanics of rent control.

I ask because property managers can sometimes take issue with campaigners knocking on their tenant's doors (even though, frankly, it's not really up to them).
