Hi Stephanie and Chance,

Just wanted to make sure you both saw the <u>draft email/memo</u> I put together summarizing how I thought we left things yesterday following the call. Please feel free to use as you see fit. Leah (cc'd) also reviewed it and left a comment.

I also spoke with Lucie (cc'd) from Legal Aid of Marin today and she confirmed that Legal Aid could play the roles we hoped for:

- 1. Liaising with tenants and landlords who wish to file a petition
- 2. Community education and outreach
- 3. Sending letters to landlords who attempt unlawful rent increases or evictions

Better yet, they are willing to do it for free while the program gets up and running and will then assess if and how much they may need to be compensated for a longer-term arrangement. The one wrinkle that Lucie is looking into is how to deal with landlord petition inquiries, since technically once they get information from a landlord, they wouldn't be able to support their tenant if they faced an unlawful rent increase or eviction. She thinks there is a way to deal with that by delegating those inquiries to pro-bono help connected to, but separate from, Legal Aid. She will keep us posted.
